# **Staff Reports**

#### SMHO Executive Director Reitz presented the following updates:

A scholarship fund was formed many years ago as a separate 501(c)(3) and gave scholarships to SMHO residents who were attending college. Over the years less and less SMHO residents utilized the scholarships, so it was opened to low-income students in Littleton. Interest has continued to decline, and it has been decided to end the scholarship program as it is currently constructed. The Englewood Rotary has agreed to administer the scholarship fund, as they already have a program in place.

State, County, and Local elected officials, as well as staff from local municipalities will be taking part in a tour of the Western portion of Arapahoe County on September 25<sup>th</sup>. The group will stop at Overlook to view the property and hear a short presentation from SMHO staff.

Foster Youth to Independence (FYI) update—Executive Director Reitz has been meeting with Arapahoe County and CASA staff to determine next best steps to ensure supportive services are being offered to the participants of the program. The wraparound services are a key factor in the program and are necessary to ensure participant success. Stakeholders are reviewing areas for process improvement and hope to have new concepts in place within the next couple of months.

## **Emerald Point Discussion**

SMHO staff presented an overview of the Emerald Point parcels and the options available in terms of the future use of the property in the development/re-development of the property. The Real Estate Committee shared their opinions and preferences for the use of the property, which were differing thoughts regarding the preference for multi-family or for-sale affordable duplexes. It was decided that more discussion would be needed to reach a resolution and consensus, and that discussion would take place at the October board retreat.



# **Commissioner/Committee Reports**

Governance Committee—the committee is working on completing Executive Director Reitz' annual performance appraisal, updated Job Description, and contract.

The Real Estate Committee gave an update on several initiatives, including sales of the Habitat homes, the Sullivan, and Overlook.
