Staff Reports

SMHO Executive Director Reitz presented the following updates:

The Health Insurance renewal process is underway and rates from different carriers are being collected by the brokers. It appears the premiums for 2024 will decrease, the amount of the decrease dependent on which carrier and plans are selected. There should be significant savings in the budget. Still waiting on two more quotes before a decision can be made.

SMHO is working with city staff on a regular communication strategy and updates to council regarding housing. The Governance Committee is also working on a plan.

The PHADA—Public Housing Authority Director's Association—Commissioner Conference is happening January 7-10 (Sunday-Wednesday) in San Diego.

The Overlook grand opening event will most likely happen the 2nd week of January (most likely the 10th or 11th).



SMHO Director of Operations Robinson-Thibault presented the following updates:

Vacancy rates are decreasing and going forward all waiting lists will be left open indefinitely. Except for Amity Plaza, all properties are now in the Rent Café portal online. The vacant Occupancy Specialist position may be changed or combined with another position.

SMHO is still recruiting for the open Property Manager position for the Low-Income Housing Tax Credit (LIHTC) properties.

Report from Council Member Milliman

Council member Milliman presented the following updates:

Council member Milliman did not run for re-election, so the November meeting was her last meeting as the SMHO liaison. Council member Milliman stated that she will continue to support SMHO and their vision, even though she will no longer be a council member.

SMHO staff and board expressed their gratitude toward Council member Milliman. She was very engaged and enthusiastic while serving as the liaison.

Commissioner/Committee Reports

Commissioner Stillwell talked to an organization that assists with weatherization projects and will connect them with staff.

The Governance Committee reported on the creation of a formal communication plan for staff and the board, with the goal of consistently providing updates and information to City Council and the community. Some ideas include utilizing scheduled public appearances at City Council meetings, as well as the 3-minute public comment opportunity. Talking points would be reviewed by the entire board before presenting the information.

Financial Reports

Staff and the Finance Committee presented the financial reports ending August 31, 2023 and September 30, 2023. A high-level overview was provided and changes to account balances, budget variances, and vacancies were examined.
