SMHO Executive Director Reitz presented the following updates:

The Amity Plaza elevator jack replacement has been completed.

A staffing update was given, as well as an update on a potential 3rd party property management company that would oversee Amity Plaza. SMHO's first intern will be starting work on the property management team. The internship program is a partnership with Littleton Public Schools' EPIC Program.

Executive Director Reitz and another staff member recently attended a Novogradic Housing Tax Credit conference. Novogradic provides Low-Income Housing Tax Credit (LIHTC) consulting services and is one of the leaders in the affordable housing tax credit industry.

SMHO staff recently learned that Arapahoe County funding for Montview Flats is going to be much less than anticipated, leaving a large financing gap in the project.
